

# **Rules of QUEEN ELIZABETH'S HOSPITAL OLD BOYS SOCIETY PRIZE DRAW**

(Registered under Section 5 of the Lotteries and Amusements Act 1976)

**No. LO: 017290**

The Prize Draw shall be formally known as the QEHOBS Prize Draw.

The purpose of the Draw shall be to raise additional funds for the QEH Old Boys' Society Benevolent Fund (The Benevolent Fund)

Note. In this document, "Members" refers to stakeholders in the Draw, not members of the Old Boys Society (The Society)

1. Participation in the Draw is open to all past and present pupils and staff members of QEH, and their family and friends (minimum age 16). Participant names will only be entered into the Draw when the Prize Draw Account has been credited with their relevant Annual or Quarterly payment.
2. Operation of the Draw shall be administered by five Trustees, drawn from former pupils of the school (and of whom a minimum of two shall be members of the Executive Committee of the Society) who are able to approve distribution of amounts up to £200 to members from each monthly draw
3. Distribution of sums greater than this will be referred to the Society's Executive Committee for approval. As at 1<sup>st</sup> November 2016 ) the Trustees are:-  
Chris Bater (who shall act as the Promoter), Karl Suchy, John Tottle, Ron Trott and Mark Budd.
4. The Trustees will be able to make any amendments to these Procedures that they judge necessary, Members being given notice through the medium of the website of the Society.
5. The maximum number of Members shall not exceed 300
6. The purchase cost of each unit in the Draw is £1 per week, payable either annually (£52) or quarterly (£13) by Bank Standing Order.
7. The Trustees have set up a separate bank account to handle all money associated with the Draw.
8. The Administrative costs of running the Prize Draw, approved by the Trustees, shall be met from the Account.
9. The draws will be made monthly during the first Week of each Month and a minimum of 3 Trustees must attend each draw.
10. After deduction of Administrative costs, the stake money relative to each month will be allocated 50% to Prizes and 50% to The Benevolent Fund
11. Immediately following each draw, the calculated Prize Money will be distributed as follows :  
One Prize of 50% of the Prize Money  
Three Prizes of 12.5 % of the Prize Money  
The final 12.5% of the Prize Money will be carried forward to create an extra Grand Prize (of an amount to be decided by the trustees) to be drawn in addition to the normal prizes, in the November and Summer draws.
12. The names, and amount, of all winners will be published on the website of the Society.
13. On termination of the Prize Draw, Members will be given three months' notice, and any money remaining in the Account will be allocated to The Benevolent Fund
